With the preparatory office established in October 1962, the Institute of Economics was officially set up in February 1970. In the early stage, we put more emphasis on public policy research and contributed to the empirical study of Taiwan's economy and government policy analyses. Important research reports, such as *Issues of Contemporary Taiwan's Commodity Prices*, *The Direction and Strategy of Taiwan's Economic Development*, *Taiwan's Human Resources*, *Taiwan's Econometric Models*, *Taiwan's Income Distribution*, and *Taiwan's Financial Development*, have been released in the 1970s and 1980s. In recent years, we not only cover empirical and theoretical research, but also have a rigorous system concerning our researchers' promotion, employment renewal, and evaluation. During the recent half a century, we have contributed greatly in aspects including talent cultivation, academic research, researches and suggestions on economic policies, and civil service.

We take responsibility for promoting the standard of economic research in Taiwan. In 1970, we began the publication of Taiwan's first economic forecasting journal, *Taiwan Economic Forecast*, which was renamed *Taiwan Economic Forecast and Policy* in 1988 to reflect a shift in its focus and scope to cover public policy research. *Taiwan Economic Forecast and Policy*, founded by Academician Dr. Tzong-Shian Yu, is a biannual journal that focuses not only on economic forecasting figures but also on public policy research, forecast, simulation and methods of evaluation. Another locally influential publication, *Academia Economic Papers*, was founded in 1973. *Academia Economic Papers* is a quarterly journal of general interest. It is the first domestic journal to be indexed by the *Journal of Economic Literature*. Both journals are indexed by the Taiwan Social Science Citation Index (TSSCI), with the latter ranking top 1 among the indexed journals.

As of the beginning of 2022, we have 31 full-time research staff members, including 5 distinguished research fellows, 11 research fellows, 6 associate research fellows, and 9 assistant research fellows. In addition, we have 4 correspondence research fellows, 1 joint-appointment research fellows, and 7 adjunct research fellows. The research fields of our research staff members cover economic theory, econometric theory and applications, macroeconomic and monetary theory, public economics, international trade and

finance, regional and urban economics, industrial organization, agricultural and environmental economics, labor economics, and health economics. The content of research includes new developments of theories and methods, empirical analyses and policy research, both internationally and locally.

Many of our research staff members have made great academic achievements. Their papers have been published in top journals, e.g., *Econometrica*, *Review of Economic Studies*, *Science*, *PNAS*, *Journal of Economic Theory*, *American Economic Journal: Economic Policy*, *Journal of Econometrics*, *Econometric Theory*, *European Economic Review*, *International Economic Review*, *Games and Economic Behavior*, *Journal of Business and Economic Statistics*, *Journal of Health Economics*, *Journal of Human Resources*, *Journal of International Economics*, *The RNAD Journal of Economics*, *Journal of Money, Credit and Banking*, *Journal of Public Economics*, etc.

Because of their outstanding achievements, many of them have received prizes and honors awarded by the government and various academic institutions, e.g., Presidential Science Prize, Outstanding Achievement Award in Science and Technology (Executive Yuan), Outstanding Research Award, Young Faculty Award, and Young Scholar's Creativity Award (Foundation for the Advancement of Outstanding Scholarship), Research Achievement Award (Ministry of Education), Outstanding Research Award, Ta-You Wu Memorial Award (Ministry of Science and Technology, former National Science Council), Academia Sinica Research Award for Junior Research Investigators, as well as elected Academician and Young Affiliate of The World Academy of Sciences TWAS, and elected Academician of Foreign Associate of National Academy of Sciences.

Since 1973, under the leadership of former director Dr. Tzong-Shian Yu, Dr. Paul K. C. Liu, and Dr. Yung-San Lee, we have hosted

a series of conferences and workshops on Taiwan's current economic issues, such as Conference on Current Price Problems in Taiwan, Conference on the Directions and Strategies of Taiwan's Economic Development, Conference on Income Distribution in Taiwan, Conference on Human Resources in Taiwan, and Conference on Foreign Trade of Taiwan, and many others on urban development, agricultural development, industrial developments, financial development, etc. The papers presented in these conferences have been important references for policymakers. The institute has also participated in drafting policy white papers published by Academia Sinica, such as *Tax Policy Reform Recommendations* and *Taiwan Industrial Reform and Competition Strategy Proposal*, to raise awareness about crucial social development for state references. Currently, we are developing *Taiwan's Monetary and Financial Reform Proposal*, which is to be issued in 2020. Now, colleagues of our institute also involve in a few notable policy research and programs, for instance, National Health Insurance, National Pension, and Environmental Protection among others.

To enhance Taiwan's international exposure, we cooperated with the Chung-Hua Institute for Economic Research to host the Chung-Hua Economic Lecture Series since 1980. Through this lecture series, we have invited many distinguished economists to deliver lectures, including Leonid Hurwicz, Clive W. J. Granger, and Robert F. Engle. Many of these scholars were awarded the Nobel Memorial Prize before or after delivering the lecture. Since the early 1990s, we have hosted numerous important international conferences. For example, the 14th Pacific

Regional Science Conference (1995), the 2nd Pan-Pacific Conference on Game Theory (2005), Association for Public Economic Theory Annual Conference (2012), International Conference on Socioeconomic Determinants and Consequences of Public Health (2012), the Far Eastern Meeting of the Econometric Society (1993, 2007, and 2014), Society for the Advancement of Economic Theory Annual Conference (2018), and Society for Economic Dynamics Annual Meeting (2025).

At last, many of our research staff members have participated in policymaking, economic statistics, and econometric analyses such as Taiwan's National Health Insurance system, the National Pension Insurance, and environmental protection policies. Many of their suggestions have been incorporated into current social and economic policies. Some of our colleagues have played an important role in the government. For example, our former director Dr. Tzong-Shian Yu participated in building a macroeconomic model for the Executive Yuan and served as a member of the National Income Statistics Committee of Directorate General of Budget, Accounting and Statistics, Executive Yuan. Dr. Ta-Chung Liu was invited to

chair the Financial Reform Commission in Executive Yuan. Dr. Mo-Huan Hsing, Dr. Fu-Chi Liu, and Dr. Tzong-Shian Yu were also invited to the aforementioned commission to provide suggestions on reforming the financial system and economic

development. Since the 1990s, Dr. Yung-San Lee, Jia-Dong Shea, Sheng-Cheng Hu, Cyrus C. Y. Chu, and Chung-Ming Kuan have served as ministers in the cabinet, devoting themselves to public services and the economic development of our country.



本所於 1962 年 10 月成立籌備處，1970 年 2 月正式成立研究所，經過筆路藍縷、人才培育與積極發展等階段，至今將屆六十年。創所初期，以政策研究為重點。同仁對台灣經濟的實證研究與政策分析貢獻良多，先後完成「當前台灣物價問題」、「台灣經濟發展方向及策略」、「台灣人力資源」、「台灣經濟計量模型」、「台灣所得分配」、「台灣金融發展」等大型專案研究計畫。近年來，本所除兼顧實證與理論研究外，同時建立了嚴謹的研究人員升等續聘評鑑制度。在這個長達半世紀的期間，本所對於人才培育、學術研究、經濟政策研究與建言、及社會服務等方面都有長足貢獻。

在台灣，本所亦肩負協助提升國內經濟學領域研究水準的責任。於 1970 年創立的《臺灣經濟預測》半年刊，由于宗先先生策劃完成，除發布經濟預測數據外，也以政策研究與評估、預測、模擬及評估方法等為研究重點，是國內最早的經濟預測刊物。為因應經濟政策分析的需求，該刊於 1988 年更名為《臺灣經濟預測與政策》。另一份期刊，《經濟論文》季刊則於 1973 年發行，出版各種經濟理論與實證的論文，是國內第一份被列入美國經濟學會 *Journal of Economic Literature* 的期刊。這兩份期刊均被列入「台灣社會科學引文索引」(TSSCI) 資料庫，後者更為該資料庫排名第一的期刊。

目前 (2022 年) 本所共有 31 位研究人員，其中特聘研究員 5 人、研究員 11 人、副研究員 6 人、及助研究員 9 人；另有通信研究員 4 位、合聘研究員 1 位及兼任研究員 7 位。研究領域包括：經濟理論、經濟計量理論與實證、總體經濟與貨幣理論、公共經濟、國際貿易與金融、區域與產業經濟、農業、天然資源與環境經濟、人口與勞動經濟、及醫療與福利經濟等。研究內容涵蓋理論與方法的新發展、實證分析及政策探討，並兼顧國際化與本土化。

至今，本所同仁於經濟理論與實證研究等方面已有卓越的績效。所獲得的學術獎項與榮譽更是不勝枚舉，包括總統科學獎、行政院「傑出科技榮譽」、傑出人才發展基金會之「傑出人才獎座」、「積極爭取國外優秀年輕學者獎助」、「年輕學者創新獎」、教育部「學術獎」、科技部 (原國科會)「傑出研究獎」與「吳大猷先生紀念獎」、本院「年輕學者研究著作獎」、以及國際學術組織世界科學院「院士」與「青年學者」、美國國家科學院外籍「院士」等殊榮。本所同仁近年來在國際著名經濟學期刊及專書上發表近百篇論文，包括：*Econometrica*, *Review of Economic Studies*, *Science*, *PNAS*, *Journal of Economic Theory*, *American Economic Journal*, *Economic Policy*, *Journal of Econometrics*, *Econometric Theory*, *European Economic Review*, *International Economic Review*, *Games and Economic Behavior*, *Journal of Business and Economic Statistics*, *Journal of Health Economics*, *Journal of Human Resources*, *Journal of International Economics*, *The RNAD Journal of Economics*, *Journal of Money, Credit and Banking*, *Journal of Public Economics* 等。

在經濟政策研究與建言方面，自 1973 年開始，本所在于宗先所長、劉克智所長與李庸三所長的領導之下，舉辦了一系列有關重要經濟問題的學術研討會，如「當前台灣物價問題研討會」、「台灣經濟發展方向及策略研討會」、「台灣所得分配會議」、「台灣人力資源會議」及「台灣對外貿易會議」，還有都市發展、農業發展、工業發展、金融發展等國內外會議，並將會議論文出版成專書，供政府施政參考。另於 2014 年與 2017 年參與研擬本院《賦稅改革政策建議》及《臺灣經濟競爭與成長策略政策建議》之建言白皮書，對社會發展重要議題，提供政府施政參考。目前正在進行的建言白皮書為《臺灣貨幣金融改革政策建議》，預計於 2020 年完成。本所同仁亦參與多項重要

政策研究與規劃工作，如全民健康保險、國民年金、環境保護等。

為了促進國際間對我國經濟、社會與學術的了解，並提升研究水平，自 1980 年開始，本所和中華經濟研究院共同推動「中華經濟演講系列」，每年邀請不同的國際傑出經濟學者來台發表演講，其中包括 Leonid Hurwicz、Clive W. J. Granger、Robert F. Engle 等十多位諾貝爾經濟學獎得主。這些來訪之國際知名學者大大提升了我國的國際能見度。1990 年之後，學術研討會的召開也日漸頻繁，研討議題

的涵蓋範圍日漸深廣，影響力也逐年增加。由本所主辦的國際重要學術會議，包括「1993 年世界性經濟計量學會遠東會議」、「第十四屆太平洋區域科學會議」(1995)、「2005 年第二屆泛太平洋賽局理論國際會議」、「2007 年經濟計量學會遠東地區會議」、「2012 Public Economic Theory 年會」、「2012 年公共衛生之社會經濟要素與成果國際研討會」、2014 年由本所第三度主辦的「The Econometric Society 亞洲會議」，以及「2018 Society for the Advancement of Economic Theory 年會」，與預計於 2025 年舉行的「Society for Economic Dynamics 年會」等，都屬國際間主要學術活動。

最後，在社會服務方面，本所同仁經常參與政府部門的政策規劃、經濟統計與計量分析工作，也有不少同仁直接服務於政府部門，成為政府團隊成員，或以不同方式運用專業協助社會經濟發展。于宗先先生於 1968 年起受聘為行政院全國總供需估計模型編審小組之設計委員 (該小組於 1972 年併入行政院主計處國民所得統計評審委員會)，並於 1970-2015 年擔任行政院主計處國民所得統計評審委員會之委員及該委員會之設計會議召集人，另兼任行政院主計處駐處委員 (行政院主計處因組織改造，於 2012 年更名為行政院主計總處)。1968 年政府成立「行政院賦稅改革委員會」，敦聘劉大中先生為主任委員，邢慕寰、柳復起及于宗先三位先生，也都被羅致在內，繼續以其專業協助制度改革及國家發展。他們所奠定的優良傳統，影響同仁日後陸續投入國家政策與制度的制定與改革行列。1990 年起，李庸三、許嘉棟、胡勝正、朱敬一、管中閔等多位同仁也陸續被政府延攬入閣，成為政府團隊的成員，直接投入國家經濟發展與社會服務的行列。

Academia Economic Papers 經濟論文

Academia Economic Papers is a journal published by the Institute of Economics, Academia Sinica. It was founded in 1973, first started as a biannual journal and then a quarterly journal since 1996. *Academia Economic Papers* has received Distinguished Journal Publication Prizes awarded by the National Science Council (Taiwan) in 1998 and from 2001 to 2004.

To pursue even better academic qualities, *Academia Economic Papers* has invited notable domestic and foreign scholars to serve as the members of the editorial board.

Academia Economic Papers has been indexed in TSSCI since October 2000 and is now indexed in international databases including Cabell's Directory, EBSCO, Gale, ProQuest and Scopus. The abstracts of papers in *Academia Economic Papers* are also listed in the EconLit published by the American Economic Association. Meanwhile, according to the "Notice of Review for Research Projects in Economics" issued by the Ministry of Science and Technology in 2015, *Academia Economic Papers* has been ranked at a level between tiers B+ and B among international journals.

《經濟論文》創於 1973 年，由中央研究院經濟研究所出版，原為半年刊，1996 年起改為季刊。每年三月、六月、九月及十二月各出版一期。自 1994 年起本刊文章摘要收錄於美國經濟學會所編輯之電子版的「經濟文獻索引」(EconLit)。而於 1998、2001、2002、2003、2004 年獲選為國科會傑出期刊；1999、2000 年獲選為國科會優良期刊。自 2000 年 10 月起收錄於「臺灣社會科學引文索引核心期刊」(TSSCI) 資料庫。

近年並受邀收錄於 Cabell's Directory、EBSCO、Gale、ProQuest 及 Scopus 等國際資料庫。此外，在科技部「經濟學門專題研究計畫審查須知」(科技部，2015) 中，本刊被列為等同於國際期刊的 B+ 級和 B 級之間。



Taiwan Economic Forecast and Policy 臺灣經濟預測與政策

Taiwan Economic Forecast and Policy was first published in March 1970, following the establishment of IEAS in February. It was initially named *Taiwan Economic Forecast* and was renamed since 1988. It carries biannual reports, in March and October, of yearly forecasts for Taiwan's economy and publishes papers on the analyses of economic policies. For the past 50 years, it has become an academic journal that covers economic forecast, policy research and empirical study, becoming an important reference for Taiwanese academia, government, and industries.

Taiwan Economic Forecast and Policy is now indexed in international databases including EBSCO and ProQuest. Also, the abstracts of papers in *Taiwan Economic Forecast and Policy* are listed in the EconLit published by the American Economic Association. In 2017, it was listed as a journal of first degree in economics in Research Institute for the Humanities and Social Sciences, Ministry of Science and Technology's "Journal Evaluation and List of Core Journal in the Humanities and Social Sciences in Taiwan".

《臺灣經濟預測與政策》為中央研究院經濟研究所於 1970 年 2 月正式成立後，鑑於經濟預測與政策研究之重要性，於同年 3 月所創刊發行的學術期刊。創刊之初原名《臺灣經濟預測》，後於 1988 年更名為《臺灣經濟預測與政策》。本刊於每年三月及十月定期出刊，發行迄今已有 50 年的歷史，並已成為經濟預測、政策研究與一般實證研究兼重之經濟學專業期刊，提供產官學各界參考。

本刊現已收錄於 TSSCI、ProQuest、EBSCO 等國內外重要的文獻索引資料庫，及美國經濟學會編輯之經濟文獻索引 (EconLit)。除此之外，並於 2017 年科技部人文社會科學研究中心「臺灣人文及社會科學期刊評比暨核心期刊收錄」中，獲評為經濟學門第一級期刊。

Tax Policy Reform Recommendations

賦稅改革政策建議 June 2014

Tax Policy Reform Recommendations is the result of Academia Sinica's research and analyses on several fiscal issues and the recommendations given thereupon, to improve the finance, to ensure the steady growth of the economy, and the sustainable development of our country.

In the white paper, our research fellows help discover some serious existing fiscal issues in our country. Because of the seriousness and urgency of these fiscal issues, they, while keeping fiscal deficits offset by tax revenue and tax-to-GDP ratio unchanged, base on an overall consideration over principles of tax equity, reasonableness, ability-to-pay, and stability of tax to provide concrete recommendations.

《賦稅改革政策建議》白皮書是由中研院召集本所同仁及院外專家學者等，共同組成研議小組，為健全我國財政，確保經濟穩定成長，國家能永續發展，針對幾項財政議題所做的研究及分析，並提出建議。研議小組最後發現目前我國明顯存在了一些嚴重之財政問題。

基於這些財政問題之嚴峻及急迫性，在彌補財政赤字後，並維持稅收佔 GDP 的比例不變的原則下，基於賦稅公平、合理、量能課稅及稅收穩定性等原則之綜合考量，也具體提出建議。

In the report, our research fellows help propose government policies that enhance the industrial competitiveness of the semiconductor industry, panel industry, machinery industry, up- and midstream of petrochemical industry, green energy industry, biotech pharmaceuticals, healthcare industry, and the financial sector.

The report hopes to maintain the industry competitiveness through new modes of thinking, innovative practices and forceful supports from government policies and promotes Taiwan's long-term economic growth in the future.
