Editorial Committee consists of eleven to fifteen members, who are nominated by the Institute's Academic Affairs Committee, and then approved in the Institute's faculty meeting. Elected committee members serve a two-year term, and are eligible to be re-elected. When a member's term is completed or the number of active members falls below eleven, the above-mentioned procedure will be followed for replacement(s). At least one third of the members are not in the Institute's full-time research faculty. The Executive Editors consist of the Director and two Editorial Committee members selected by the Director. The two Executive Editors, will serve as the Managing Executive Editors. Executive Editorial Members can invite scholars, including those who are not institute's research fellows as ad hoc committee members for consultation and assistance in economic forecasting.
